6 FURLONGS. (1.07³) GOLD FEVER S. Purse \$150,000 FOR THREE YEAR OLDS. Non-Lasix Race pursuant to 4043.2(7)(e)(5) Lasix not permitted within 48 hours of post time. By subscription of \$150 each which should accompany the nomination; \$750 to pass the entry box and an additional \$750 to start. For horses not originally nominated, a supplemental payment of \$750 in addition the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 55% to the owner of the winner, 20% to second, 12% to third, 6% to fourth, 4% to fifth and 3% divided equally amongst the remaining finishers. Weight: 124 lbs. Non-winners of a Graded sweepstake allowed 2 lbs.; of a sweepstake allowed 4 lbs.; of two races other than maiden, claiming, starter or state bred allowance allowed 6 lbs. DREW'S GOLD was bumped lightly by a foe at the start, contested the pace on the outside, vied in the two path on the turn, shook clear into upper stretch, responded well under good handling into the final furlong and drew off under strong urging. SQUIRE CREEK bumped twice with a foe just after the start, showed speed inside of two opponents then was eased back off the pace, moved out just inside the five-eighths, was roused three wide on the turn then chased the leading duo, was driven four wide into the stretch and secured the place while no match for the winner. JOEY FRESHWATER bumped twice with a rival shortly after the start, dropped back under urging, moved out around the five-eighths pole, chased four wide on the turn, was driven five wide into the stretch and weakened while able to secure the show. TUSKEGEE AIRMEN dropped well behind while void of speed, saved ground on the turn, drifted out some under a left-handed crop late and failed to threaten. ANDIAMO A FIRENZE broke out and bumped lightly with a foe then was corrected by the rider, disputed the pace on the inside of the winner, vied along the rail on the turn, dropped back into upper stretch and tired.
