6 FURLONGS. (1.074) SPEIGHTSTOWN SPRINT S. Purse \$100,000 (PLUS UP TO \$15,000 Open ATB) FOR THREE YEAR OLDS AND UPWARD. No nomination fee. \$500 to pass the entry box and an additional \$500 to start. Supplemental nominations may be made at time of entry for \$1,500 and shall include all fees. After payment of 1.5% of the purse to all owners finishing sixth through last, 60% of the remaining purse shall be paid to the winning owner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. If less than five horses start, the remaining purse will be distributed to the winning owner. Starter to be named through the entry box by the usual time of closing. Weights: Three Year Old, 121 lbs. Older, 124 lbs. Non-winners of \$25,000 in 2023 allowed 2 lbs.; Non-winners of \$15,000 since November 29, 2022 allowed 4 lbs.; Non-winners of \$15,000 in 2022 – 2023 allowed 6 lbs. Maiden and claiming races not considered in weight allowances. Total earnings in 2022–2023, as determined by the information provided by Equibase Company, will be used in determining the order of preference. The field will be limited to fourteen starters. Horses not drawing a starting position in the gate will receive a refund of the entry of the entry fee. A trophy will be presented to the winning owner.

SKELLY broke a half step slow, immediately took command in the first few strides, opened a well rated advantage while racing in the two path, shook off the pace pressers turning for home and finished well while never having been seriously threatened. ALBIZU stalked the leader from the rail, was in tight for one stride into the turn, rallied well up the fence for the place and was second best. JACKMAN chased the leaders from three wide to be prominent throughout but could not close the gap in spite of a good effort. DEAN'S LIST reserved off the leaders to the top of the stretch and mounted a mild rally to just miss the show. ERNIE BANKER prompted the pace from two wide to the quarter pole and gave way in the lane. GO WEST broke alertly, settled into stride showing brief speed for an eighth, dropped back off the pace down the backstretch and failed to respond when called upon. THE TRAINER OF THE ALBIZU FILED AN OBJECTION AGAINST SKELLY FOR INTERFERENCE ON THE TURN, AFTER REVIEW THE STEWARDS RULED NO CHANGE WAS TO BE MADE
