KALIK strolled to the front, went around the first turn in the two path, was well rated on an uncontested lead, controlled the action while inside to the two path on the far turn, responded well when asked inside the quarter-pole, came under a right-handed crop outside the furlong marker, remained clear into the final sixteenth and held under strong urging. FAR BRIDGE traveled around the first turn in the two path, was reserved towards the back, came under coaxing near the nine-sixteenths, was urged two then three wide on the far turn, steadied while blocked behind horses in upper stretch, altered in for room outside the furlong marker, gained on the winner into the final sixteenth and finished with good energy but was too late while just able to get the place. SILVER KNOTT (GB) was last to commence then dropped to the inside, saved ground while reserved off the pace, was asked near the five-sixteenths then moved to the two path, shifted four wide at the top of the stretch, pursued the winner while outside into the final furlong, gained into the final sixteenth and just missed the place while clear for the show. LACHAISE was rated on the inside, saved ground through the far turn, was asked at the quarter-pole, chased under a drive into the final furlong and weakened. FREEDOM TRAIL raced in the three path on the first turn, stalked the pace on the outside, issued a challenge in the two to three path on the far turn, lost touch with the winner under a drive in upper stretch, dropped back into the final furlong and also weakened. CONGRUENT checked while tossing his head rankly off heels nearing the first turn, tossed his head again while three then four wide going around that bend, threw his head yet again while dragging his way forward leaving the backstretch, was rated on the outside, went three to four wide while roused on the far turn, spun five wide into the stretch and lacked the needed kick. BELOUNI (FR) was taken under a tight hold early, tugged eagerly on the bit while two then three wide on the first turn, remained under stout restraint onto the backstretch then settled more kindly at the rear, went three wide for most of the far turn then shifted five wide, came six wide into the stretch and lacked the needed response.
