CLOSING ACT brushed with a foe just after the start, was urged along on the outside, went four then three wide on the turn, gained to make a bid coming to the quarter-pole, took over the lead in upper stretch, shook clear under a right-handed crop into the final furlong and drew a way under strong urging. UNION SUIT was hustled to the front, showed the way under pressure from her outside, vied inside on the turn, shook clear at the seven-sixteenths pole, lost the advantage to the winner under urging in upper stretch, dropped back into the final furlong then moved out and proved no match for the winner while clear for the place. LIVING MAGIC brushed with a rival just after the break, was squeezed back between horses early, went two then three wide on the turn, came four wide into the stretch, gained while remaining on her inside lead in the drive and secured the show. GOLDEN GHOST (GB) pressed the pace on the outside of the leader, vied in the two path on the turn, dropped back near the seven-sixteenths, chased into the stretch and tired. DONATE LIFE chased the pace, dropped from the three path to the rail on the turn, climbed into the kickback in the vicinity of the five-sixteenths and retreated.
