By subscription of \$50 each, which shall accompany the nomination \$350 due at time of entry and \$650 additional to start, which shall be due at noon, day of the race. \$100,000 Guaranteed (Includ es \$35,000 OTF), of which 60% to the winner; 20% to second; 10% to third; 5% to fourth; 3% to fifth; 2% to sixth. Equal Weights Three Years–Old 119 lbs Older 124 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to twelve (12) horses with preference to start given to those with the highest total earnings in 2022–2023. Should this race be determined to run on the dirt the distance will remain the same. Failure to draw in cancels all fees. Lasix is not permitted in this race. Trophy presented to the winning owner. Nominations closed Tuesday, May 23, 2023 with 18 nominations. (If transferred to the Main Track, this race will be run at One Mile and a Sixteenth.) (Rail at 14 feet).**

DARK VADER was steadied into the first turn, chased the pace early, was off the rail into the lane, made a bid but flattened out late in the drive. TANTRUM was steadied into the first turn, chased the pace, was on the inside into the lane with a minor gain in the stretch run. SILENCE raced back early on, was in the five path into the lane with a belated gain in the stretch drive. SEND ME ON was steadied into the first turn, off the rail into the lane and leveled off late in the stretch. TO WIN chased the pace early, was in the four path into the lane and faded late in the stretch. VISUAL MISSION was never a threat. DANEFIELD was bothered at the start, stalked the pace early, was in the three path into the lane and empty late. FIRSTHAND JUSTICE broke out at the start, was checked into the first turn.
