6 FURLONGS. (1.071) PRAIRIE ROSE S. Purse \$50,000 FOR FILLIES & MARES, THREE-YEAR-OLDS & UPWARD. Weights: Three-Year-Olds - 120 lbs.; Older - 125 lbs. Non-winners of \$60,000 in 2022-2023 allowed 2 lbs.; non-winners of \$45,000 in 2022-2023 allowed 4 lbs.; \$30,000 in 2022-2023 allowed 6 lbs. (Maiden and claiming races not considered) No nomination fee. \$250 to pass the entry box. \$250 additional to start. \$50,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$750 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds twelve (12), high weights will be preferred. Different owners will have equal draw according to weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees.

MY FIRST PEARL broke on top then taken in hand and settled in the back, continued unhurried entering the turn, given cue four to five wide turning for home, kicked in gamely, rallied strongly along the outside and swept by late. SPANISH DELIGHT was forwardly place in opening stages then took over the lead approaching the half mile marker, set the pace and remained clear still unleashed around the turn, roused for more at the head of the lane, responded, widened advantage then got run down in deep stretch. DEALING JUSTICE rated off the early pace although never too far back, picked up the tempo three wide mid-way around the turn, sustained a three to four wide bid down the lane and produced a solid finish. ALBERTA SUN raced in contention and tracked the pace up the backstretch, was ridden along two wide around the turn, sustained a three wide bid into the final furlong then evened out in late stages. PRINCE DREAMCESS chased the pace up the backstretch, hustled along two wide into the lane, advanced in contention a furlong out then gave way. ADRIA briefly held the lead in opening stages then conceded position approaching the half mile marker, remained in contention along the inside around the turn then came up empty in the lane.
