1¹/₁₆ MILES. (1.421) COUNT LATHUM H. Purse \$50,000 (includes \$500 Starters Bonus) A HANDICAP STAKE FOR THREE-YEAR-OLDS. A fee of \$100.00 required to nominate. A payment of \$500.00 is required to pass the entry box and an additional \$400.00 is required to start. The purse will be divided \$30,000 to the owner of the winner, \$10,000 to the second place finisher, \$5,000 to the third place finisher, \$2,500 to the fourth place finisher and \$1,000 to the fifth place finisher. A payment of \$500 will be paid to all horses who start and finish 6th or worse. High weights preferred. Starters to be named through the entry box by the closing time of entries. The field will be limited to 12 starters. A trophy will be presented to the winning owner.

AMERICAN BLAZE saved ground while three to four wide, advanced outside through the final turn, responded to handling in a long drive, dug in gamely deep stretch, and narrowly prevailed. KAUAI DAN was crowded at the start, dropped back in the opening turn, gained closer order from along the rail leaving the back stretch, struck the front after the quarter pole, weakened deep stretch under handling, and was bested. KYSTONE saved from the rail, drove four wide on the final turn, chased the leader under steady urging, and was outkicked. RIVERSIDE trailed in the early stages, raced wide through the back stretch, came under heavy urging into the stretch, was gaining late, and needed more ground. IT'S A FACT was outsprinted to the turn, raced in closest pursuit of the leader, and lacked a rally. CALI CONQUEST raced three wide in the opening turn, was widest through the back stretch, and past tiring rivals. MUDINATOR sent for outside speed, was reserved off the pacesetter from the three path, and came up empty in drive. NORTHERN JEWEL saved ground and lacked a bid. READY TO TAPNSING hustled to the front setting the early pace, moved to good margins through the back stretch, saw the gap close nearing the quarter pole and faltered.
