AMY C (GB) was off slow and brushed leaving the gate, steered down to the inside, had to pause running up behind a rival into the turn, shifted to the two path around the bend, steered out in upper stretch, closed in entering the final sixteenth and bested TONY ANN late. TONY ANN sat off the pace early on, gained two wide between rivals around the bend, rallied inside the leader in deep stretch but got outclosed by the winner. PRINCESS ADALEIGH pressed the pace from outside early, failed to stay with the leader and chased while two, three, then four wide around the bend, came again entering the final sixteenth but was outkicked. SASSY NATURE set the pace under pressure from PRINCESS ADALEIGH early, cleared that rival on the turn, drifted three wide around the bend, remained clear into the final furlong, challenged by rivals on both sides with a sixteenth remaining and weakened after being overtaken. UNBRIDLED MARY chased from off the pace two wide into the turn, angled four wide around the bend, summoned a mild rally but needed to find more late. WIDE WEST (IRE) stalked the pace from inside into the turn, moved out at the top of the lane, came back in to bother rival past the eighth pole and flattened in deep stretch. TWILIGHT GLEAMING (IRE) settled inside, lacked room when boxed on the turn, gained an opening at the top of the stretch, looked to rally but was impeded by WIDE WEST (IRE) and had to take up, then could not regain momentum after. XMAS SURPRISE broke a step slow and brushed with inner rival, trailed on the inside then in the two path, moved out in the lane and failed to make an impact. SECRETS TOLD chased three wide and weakened down the lane. FOLLOWING AN INQUIRY, THE STEWARDS DISQUALIFIED WIDE WEST (IRE) FROM SIXTH TO SEVENTH FOR CROSSING OVER AND TAKING THE PATH OF TWILIGHT GLEAMING (IRE) NEAR THE EIGHTH POLE, COSTING THAT RIVAL A CHANCE AT A BETTER PLACING.
