HOW DID HE DO THAT secured inside position around the first turn and tucked in nicely just off the early pace, let out a notch and loomed up three wide near the quarter pole, challenged ONE IN VERMILLION at the head of the lane, battled outside of rival into the final furlong, got carried out a path and bumped by aforementioned foe in deep stretch then finished on equal terms for the win.
