**5½ FURLONGS. ( 1.014 ) GRADUATION S. Purse \$125,000 ( includes \$1,000 CBOIF – California Bred Owner Fund ) FOR GOLDEN STATE SERIES ELIGIBLE CALIFORNIA BRED OR CALIFORNIA SIRED TWO-YEAR-OLDS. By subscription of \$125 each, which shall accompany the nomination, Closed Thursday August 3, 2023 with 10 or by supplementary nomination of \$1,250 each. (non-Golden State Series eligible horses, \$25,000 to supplement — which will make that horse eligible to all future Golden State Series Stakes) by closing time of entries. All horses to pay \$1,875 additional to start, with \$125,000 Guaranteed, of which \$71,250 to first, \$23,750 to second, \$15,000 to third, \$7,500 to fourth, \$5,000 to fifth and \$2,500 to sixth. Weight 122 lbs.; Non-winners of two races other than claiming allowed 2 lbs.; of a race other than claiming, 4 lbs. High weights preferred. Total earnings in non-claiming races will be used in determining the preference of horses with equal weights. A trophy will be presented to the winning owner.**

 LORD PRANCEALOT sped clear and crossed over, felt some pressure from outside on the turn before clearing again past the quarter pole, put to right handed urging and held over the late bid from LAST CALL LONDON in the closing moments. LAST CALL LONDON broke a step slow and lost his path at the start, climbed a bit then settled into stride and started to gain along the fence up the backstretch, saved ground through the turn, moved off the fence in the drive, challenged the winner from outside late but ran out of time. MICI'S EXPRESS dropped back early, went two wide into the turn, advanced while easing further out and came four wide into the stretch, closed well in the final furlong and gained the show. REFOCUS stalked the leader inside a rival to the turn, put in a mild bid from outside around the bend but failed to keep up with LORD PRANCEALOT past the quarter pole, continued within range entering the final furlong but could not summon the needed late kick in deep stretch. WILD JEWELS chased widest up the backstretch, went seven wide into the turn, moved into the four path around the bend and could not rally. SHADY APPEAL stalked the pacesetter outside a rival, traveled three deep around the turn, took an awkward step entering the stretch and faded out of contention. SMOKEM EZ came away slow, chased five wide into the turn, lost ground around the bend and came three wide into the stretch and weakened. SALSATION tracked six wide into the turn, was forced to check near the five-sixteenths pole, moved in and exited the three wide and had little left for the stretch run.
