6½ FURLONGS. (1.15) SADIE DIAMOND FUTURITY Purse \$100,000 FOR BC BRED OR BC SIRE TWO YEAR OLD FILLIES. By subscription of \$50 for each mare-in-foal or foal on ground nominated on or before April 8, 2021. To remain eligible a further subscription of \$100 is due by Midnight Saturday April 1, 2023 (Two-Year-Old). Final payment of \$200 to accompany the nomination by Midnight Saturday September 9, 2023 with \$1500 to enter and an additional \$2,000 to start. \$100,000 guaranteed of which 55% goes to the winner, 20% to second, 10% to third, 5% to fourth and 4% to fifth, and 2% to sixth through eighth. Supplemental nominations will be accepted if a sustaining payment is missed, but only if the Mare in foal was originally nominated. The supplemental fee is \$5000 and due at time of entry Nominations are non-refundable. Preference will be based upon the rules outlined in Hastings condition book at the time of entry. Weight: 122 lbs. Non-winners of \$27,500 twice allowed 3 lbs. Non-winners of \$27,500 allowed 5 lbs. Non-winners of \$10,000 allowed 7 lbs. Field limited to 11 starters.

LIZZIE'S RAYNE away well and vied for the lead from the inside of VIVA LA DIVA in the run down the backstretch, continued to set a pressured pace from the inside of that rival through the final turn, got the better of her pace rival in mid stretch and held off a late surge by EDDIE'S GIRL late to prevail. EDDIE'S GIRL away alertly and stalked the dueling leaders in the run down the backside while saving ground along the inside, commenced her bid two wide entering the final turn, and was gaining late three wide in deep stretch in an impressive debut. VIVA LA DIVA dueled for the lead from the outside of LIZZIE'S RAYNE entering the backstretch, continued to press that rival two wide through the final turn, struggled to match strides with her pace rival in mid stretch, and was outfinished late. SKYSABLAZING unhurried early while trailing the field into the backstretch, commenced her bid three wide entering the final turn, and found her best stride late while finishing two out from the rail in the drive. DONNA WYN broke sharply and tracked the leaders in the run down the backstretch, rallied from along the inside entering the final turn, but was outfinished in the late going.
