NORAH G went to the front, drove clear, dueled throughout, steadied down the home stretch, getting in tight quarters and proved no match for the winner late. FREE LIKE A GIRL raced within contention, racing evenly behind the top two and lacked a late rally. WHOLELOTTAMO lacked early speed, moved up and finished evenly. EILEEN ALEXANDRA raced near the middle of the field, put forth an even effort and lacked a bid. TENSAS CANDY raced evenly in the middle of the pack and was never a factor. LOUISIANA LIBERTY raced within striking distance and faded. ALPINE MIST void of early speed and was never a threat. ZYDECO MUSIC raced near the back, moved up to the middle of the field and retreated. THE JOCKEY OF .4 NORAH G LODGED A CLAIM OF FOUL AGAINST .5 NONEYA FOR INTERFERENCE AT THE HEAD OF THE LANE. AFTER VIEWING REPLAYS STEWARDS TOOK NO ACTION.
