**5 FURLONGS. (Turf) (.533) LADIES' TURF SPRINT S. Purse \$100,000 (plus \$20,000 FTBOA - FL TB Owner Brdr Assoc Fund) FILLIES AND MARES, FOUR YEARS OLD AND UPWARD. Free nomination by Sunday, January 28. \$1,000 to enter. \$100,000 Guaranteed. A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. \*(FTBOA offer up to \$20,000 to the owners of Registered Florida-breds, divided \$10,000 to the winner, \$6,000 to second, \$4,000 to third). Weight: 123 lbs. Non-winners of a graded stakes since July 1 allowed 3 lbs.; a stakes race since April 1, or three races other than maiden, claiming, starter or state bred allowance, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners in 2023-24, stakes placed in 2023-24, then by highest career earnings. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at Five Furlongs) (Rail at 59 feet).**

STONE SILENT was prompted along while up close in the two path, bid while floating out to the five path at the top of the stretch, and drew clear. CHOOSE JOY bumped with an inner foe at the start, raced off the pace in the three path, was ridden into the turn, angled out to the seven path at the top of the lane, and ran on while on her left lead for place. FULMINATE set the pace in the two path, was cued while tipping out to the four path in upper stretch, but evened out for show. SHASTA STAR trailed in the four path, was coaxed in the three path midway around the turn, fanned out to the nine path at the top of the lane, and stayed on. BABY STEPS stalked in the three path, was cued midway around the turn, swung from the six path into the stretch, but flattened. GLITTER UP chased in the two path, cut the corner turning into the lane, but faded on her left lead. CANADIANSWEETHEART tracked in the four path, was cued between foes in the two path midway around the turn, but weakened in the stretch. THE ARCADIAN WAY bumped with an outer foe at the start, rated inside but steadied going into the turn, and was no menace.
