ONE MARK was void of any early speed, advanced ten wide through the turn, took control at the eighth pole, drifted in and edged clear. MASSIVE ROAR chased the early pace, raced off the rail into the turn, drifted out early stretch, kept on and finished second best. HENRY ON THE RUN was outrun early, made a nine wide move through the turn and finished with a mild late rally. DELBERT TOO was unhurried early, advanced four wide and passed tired rivals late. BODIE GOT GOLD was reserved early, raced three wide into the turn, shifted out far wide out of the turn and finished belatedly. SAMBAS MARK was allowed to settle early from between rivals and offered no rally. NO PASA NADA raced in mid pack early, went eight wide and never fired. MCMERCELUS pressed the early pace, raced six wide through the turn and weakened late. DIABOLICAL STORM was unhurried from the inside and was no factor. STRAWBERRY WHISKY set a pressured early pace, raced five wide and tired. ANCIENT LAND was up close early, raced between rivals and faded.
