1 MILE. (134) SUNLAND PARK OAKS Purse \$250,000 FOR FILLIES THREE YEARS OLD. Lasix not permitted per Hisa Rule 4212(d). Free to nominate; \$1,000.00 to enter. Horses that start in the Island Fashion Stakes Will Receive A Free Entry, (To The Sunland Park Oaks). Horses that were not nominated, must pay a \$10,000 Supplemental fee at the time of entry. Weight; 121 lbs. Certain finishing positions in this race will earn points to qualify for the 2024 Kentucky Oaks, pursuant to the rules published by Churchill Downs Incorporated. The winner of The Sunland Park Oaks will be awarded 20 points, the second place finisher 10 points, third place finisher 6 points and fourth place finisher 4 points. First preference to highest earnings in a graded stakes, second preference to highest life time earnings at time of closing nominations. This race will be limited to twelve starters. A suitable award will be presented to the winning owner. After payment of 1% to all owners finishing six through last, The remaining purse will be distributed as follows 60% to the winner, 22% to second, 10% to third, 5% to fourth, 3% to fifth. Nominations Closed On Thursday February 8, 2024 At 4:00 P.M. with Twenty One.

RECHARGE set the pace while racing in the two path, was well rated on the front end and confronted off the turn then was bumped leaving the furlong marker, dug in and then had a long drive and held on gamely to prove best. CANDY AISLE was allowed to settle early, moved out and made a four wide move on the far turn, then came in leaving the furlong marker and bumped the winner, fought on to the wire to just miss. SIMPLY ENCHANTING stalked the winner three wide, then was ridden along leaving the five sixteenths and was between rivals leaving the quarter pole, then faded in the drive, bested rest. METHODS was rated early, made a mild bid on the inside on the far turn but weakened. RASPBERRY WINE tracked the early pace four wide, three wide by the quarter pole and tired. THE STEWARDS POSTED INQUIRY INTO THE RUNNING IN THE STRETCH BUT AFTER REVIEW THE RACE WAS LEFT AS IS AND MADE OFFICIAL.
