**1<sup>1</sup>/<sub>16</sub> MILES. (Turf) (1.39<sup>1</sup>) ENDEAVOUR S. Grade III. Purse \$175,000 (includes \$25,000 Other Sources) FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD. Free nominations. \$600 to pass the entry box and \$600 additional to start with \$175,000 Guaranteed (which includes \$25,000 FTBOA Stakes Funds for Registered Florida Breds, which go entirely to the winner.) For those not eligible for Florida monies, 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth of the \$150,000 Guaranteed. Weight 124 lbs. Non-winners of a Grade I at one mile or over on the turf since October 1, 2 lbs.; a Grade I or II at one mile or over on the turf in 2023-24, 4 lbs; a Grade III or \$60,000 at one mile or over on the turf in 2023-24, 6 lbs. (Maiden, Claiming and Starter races not considered in estimating weight allowances). Starters and rider to be named through the entry box by the usual time of closing. SUPPLEMENTARY NOMINATIONS OF \$3,000 EACH (which include entry and starting fees) DUE BY THE USUAL TIME OF CLOSING. CLOSED SATURDAY, JANUARY 20, 2024 WITH 27 NOMINATIONS AND 1 SUPPLEMENTAL.**

WALKATHON bumped mildly with the horse to her inside at the start, recovered to lead the way while saving ground around the first turn and up the backstretch, continued to save ground around the far turn and held clear while drifting out some in the final furlong. BE MY SUNSHINE saved ground early, chased the leader on the inside up the backstretch, continued around the far turn in the two path, raced into traffic and was forced to check in the final furlong and kept on from there to hold second. SPARKLE BLUE raced off the pace on the outside through the opening half mile, came around the far bend still in the two path, began a bid in upper stretch and gained ground late. IMPLICATED bumped lightly with the horses to either side at the start, saved ground around the first bend, settled in the middle of the pack on the inside for the run up the backstretch, continued to save ground around the second turn and chased on to the wire. CONSUMER SPENDING bumped lightly with the horse to her outside leaving the gate, saved ground around the first turn, raced off the pace on the inside up the backstretch, swung out to the three and four path coming around the far bend and improved position mildly from there. FULL COUNT FELICIA tracked the leader on the outside around the first turn and up the backstretch, navigated the far turn still in the two path and weakened in the lane. WILLAKIA raced in the two path around the first turn, settled in the middle of the pack on the outside for the run up the backstretch, came around the far bend in the three path and showed no kick. THE RIDER OF HORSE ONE, BE MY SUNSHINE, CLAIMED FOUL AGAINST HORSE FOUR, WALKATHON, CITING INTERFERENCE NEAR THE EIGHTH POLE. UPON REVIEW, NO CHANGES WERE MADE TO THE ORDER OF FINISH.
