1¹/₁₆ MILES. (1.40⁴) GHOSTZAPPERS S. Grade III. Purse \$150,000 (plus \$20,000 FTBOA – FL TB Owner Brdr Assoc Fund) FOUR YEAR OLDS AND UPWARD. Free nomination by Sunday, March 17. \$1,500 to enter. \$150,000 Guaranteed. A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers up to \$20,000 to the owners of Registered Florida-breds, divided \$10,000 to the winner, \$6,000 to second, \$4,000 to third). Weight: 124 lbs. Non-winners of a graded stakes at a mile or over since September 1 allowed 2 lbs.; Graded stakes placed since then or non-winners of a non-restricted stakes race at a mile or over since August 1, 4 lbs.; three races other than maiden, claiming, starter or state-bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners 2022–24, graded stakes-placed 2023–24, non-restricted stakes winners 2023–24, then by highest career earnings. Trophy to the winning owner.

IL MIRACOLO prompted the pace in the three path, was roused while bidding between foes in the two path midway around the far turn, dug in while dueling with an outer foe from the three path into the final furlong, and inched ahead in the final strides. **TUMBARUMBA** laid up close in the four path, vied for the lead midway down the backstretch, took the lead while under a ride and three wide rounding the far turn, ran on while trying to hold off an inner foe from the four path down the stretch, but was edged out in the final strides. **STEAL SUNSHINE** chased in the four path, came under right handed encouragement in the five path midway around the far turn, fanned out to the six path at the top of the lane, and kept on for show. **LURE HIM IN** rated inside, tipped out to the three path midway around the far turn, but failed to bid. **DONEGAL FOREVER** tracked out in the five path turning into the backstretch, was coaxed from the four path early around the far turn, but made no impact from the seven path in the stretch. **X Y POINT** showed the way in the two path around the first turn, was headed by an outer foe midway down the backstretch, received a right handed cue along the inside going into the far turn, but lost the lead before the quarter, tipped out to the five path in upper stretch, and faded. **MBAGNICK (CHI)** stalked in the four path turning into the backstretch but backed up around the far turn. **THE SKIPPERTOO** trailed throughout around the six path.
