ATONE good position to far turn, moved up steadily in the stretch while no match for winner garnering the place spot gamely at the wire. FUNTASTIC AGAIN tracking three wide far turn, dueled into the stretch but weakened and just missed place spot late. TIO MAGICO no speed from the gate raced back to far turn improved late going. HARLAN ESTATE good position inside to the half with no response late going. SURLY FURIOUS unhurried from inside to far turn, mild bid into stretch, no kick. WOLFIE'S DYNAGHOST speed to chase, dueled to quarter pole with nothing left stretch. KITODAN never menaced throughout. VERSTAPPEN never far back to quarter pole with a steady fade in the stretch. WENTRU speed to the lead, dueled to the half with nothing left, faded. CURLIN'S MALIBU never factored throughout.
