DOWNTOWN MISCHIEF brushed with a rival at the start, went to the front, showed the way down the backstretch, vied in the two path while inside of a foe for most of the turn then moved to the three path, responded well when asked near the quarter-pole then extended the advantage into upper stretch, drifted out some then came under a right-handed crop near the furlong marker, turned back the runner-up into the final sixteenth and held under steady urging. MIRACLE showed speed between horses, was taken back off the pace near the three-quarter pole then switched to the outside, ranged up to prompt the leader from the outside, vied in the three path on the turn, was given her cue with three furlongs to run, lost touch with the winner while driven four wide into upper stretch, pursued the winner in the final furlong, loomed a threat again near the sixteenth-pole but was turned a way while well clear for the place. MIDTOWNLIGHTS settled on the inside of a foe, was urged two then three wide on the turn, came five wide into the stretch, moved in near the furlong marker and lacked the needed response while best of the rest. SECURITY CODE brushed with a foe at the start, dropped back on the outside, went four then five wide on the turn and was no factor. LES BON TEMPS bobbled at the start then was hustled, raced just off the pace under coaxing, chased inside on the turn and had nothing left.
