Weights: Three-year-olds 120 lbs.; Older 124 lbs.; Non-winners of \$9,000 twice in 2022-2023 allowed 3 lbs.; Of \$9,000 in 2022-2023, 5 lbs. Maiden, Claiming and Starter races not considered in allowances. High Weights Preferred, on the scale. Total earnings in 2022-23 will be used in determining the order of preference of horses being assigned equal weights. \$50 to pass the entry box and an additional \$50 to start. Nomination fee \$200 if paid by April 29th, 2023. A late supplemental nomination fee of \$1,000 (includes entry & starting fees) due at time of entry. Closed Saturday, April 29 with seven nominations. (Clear. 77.)

RECORDER bided his time while saving ground through the opening two turns, moved closer while angling out going to the final turn, rallied four wide to loop the field in that bend and drew off under steady handling. G'S TURN tracked the leaders four wide, settled back going to the final turn then regained position in the lane as rivals weakened. BARSTOW stalked the pace three and four wide in good position but weakened into the lane. DEBONNAIRE DUDE contested the pace two to three wide outside a rival and weakened in the lane. FRIENDOFTHECOURT contested the pace inside rivals while out from the rail and weakened nearing the lane.
