Weights: Three-Year-Olds 120 lbs.; Older – 126 lbs. Non-winners of \$60,000 at a mile or over in 2022–2023 allowed 2 lbs.; non-winners of \$45,000 at a mile or over in 2022–2023 allowed 4 lbs.; \$30,000 at a mile or over in 2022–2023 allowed 6 lbs. (Maiden and claiming races not considered) No nomination fee. No nomination fee. \$250 to pass the entry box and \$250 additional to start. \$50,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$750 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceed fourteen (14), high weights will be preferred. Different owners will have equal draw according to weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into race cancels all fees.**

BUTTERBEAN was allowed to settle out of the gate and saved ground around the first turn, continued unhurried in the back through early stages, picked up the tempo late on the far turn, swung five wide into the lane, roused for more, responded willingly, rallied along the outside and finished clear. MISSYINTOMISCHIEF applied pace pressure to LOFTHOUSE around the first turn and up the backstretch, edged forward and took over the lead mid-way around the far turn, widened command in upper stretch, stayed on with good response but could not hold off the late challenge from BUTTERBEAN. CLAY'S MOON STONE rated not too far off the early leaders, raced in range along the rail around the far turn, came two wide entering top stretch, waited momentarily then dove back to the rail, sustained a steady inside bid down the lane and secured a share. BOSSY MOMENT was not far back up the backstretch, hustled along three to four wide around the far turn, ran on in upper stretch then flattened out. BIG BAD DIVA stalked the pace up the backstretch, continued in range two to three wide around the far turn, came into the lane two wide and failed to move on. LOFTHOUSE set a pressured pace, got headed midway around the far turn and tired in the drive.
