**1 1/2 MILES. ( 2292 ) COUGAR II S. Grade III. Purse \$125,000 ( plus \$1,000 Other Sources ) FOR THREE-YEAR-OLDS AND UPWARD. By subscription of \$125 each, which shall accompany the nomination Closed Thursday July 13, 2023 with 9 or by supplementary nomination of \$1,250 each by closing time of entries, \$1,875 additional to start with \$125,000 Guaranteed, of which \$75,000 to first, \$25,000 to second, \$15,000 to third, \$7,500 to fourth and \$2,500 to fifth. Three-year-olds, 120 lbs.; Older, 125 lbs. Non-winners of a Gr. I race at one mile or over in 2022-2023, allowed 2 lbs.; of a Gr. II or Gr. III race at one mile or over in 2022-2023, allowed 4 lbs. High weights preferred. Total non-claiming earnings in 2023 will be used in determining the order of preference in horses with equal status. A trophy will be presented to the winning owner.**

ORDER AND LAW bumped leaving the gate, stalked three to four wide around the first turn, remained off the rail around the clubhouse turn, bobbed slightly nearing the half-mile pole, bid four deep with three furlongs remaining, fought four wide outside a pair of rivals into the lane, cleared outside the eighth pole and inched away. AZUL COAST took control from inside quickly then set the pace inside BYE BYE BOBBY, held a short lead over a pair of rivals up the backstretch, lost command at the five-sixteenths pole, fought back into the lane, could not kick on with ORDER AND LAW entering the final furlong but stayed on to hold second. BYE BYE BOBBY stalked two to three wide around the first turn, moved up to press from outside first time through the stretch, three deep up the backstretch, took over three wide at the five-sixteenths pole, lost command in upper stretch and weakened in the final furlong. KITTEN MISCHIEF hit the gate and was off slow from outside, chased four wide leaving the first turn, moved down to the two path for the clubhouse turn, applied pressure between foes up the backstretch, could not keep pace with the leaders approaching the quarter pole and weakened down the lane. GHAZAALY broke in and bumped with KISS TODAY GOODBYE repeatedly at the start, settled at the back outside a rival, coaxed along through the far turn, raced a bit off the rail into the lane and lacked arally. RIMPROTECTOR took a bump from outside at the start, steadied on the first turn, settled in the two path then moved inside, weakened around the final bend and tired. KISS TODAY GOODBYE got bumped repeatedly between rivals leaving the gate, became a bit rank when reserved on the first turn and moved inside, trailed on the last turn, eased in the lane and walked off.
