Non-Lasix Race pursuant to 4043.2 (7)(e)(5) Lasix not permitted within 48 hours of post time. By subscription of \$125 each which should accompany the nomination; \$625 to pass the entry box and an additional \$625 to start. For horses not originally nominated, a supplemental nomination payment of \$625 in addition to the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 55% to the owner of the winner, 20% to second, 12% to third, 6% to fourth, 4% to fifth and 3% divided equally amongst the remaining finishers. Weight 122 lbs. Non-winners of a race other than maiden, claiming or starter allowed 2 lbs.; all maidens allowed 4 lbs. A trophy will be presented to the winning owner. Closed Saturday, September 9, 2023 with 14 Nominations.

CALDWELL LUVS GOLD brushed with a rival at the start then was taken in hand while crowded, was urged at the rear, went four then five wide on the turn, commenced a rally coming to the quarter-pole and finished with good energy while unable to reach the winner. MY MANE SQUEEZE chased the pace on the outside then four wide on the turn and tired. MY SHEA D LADY stalked the pace on the outside, was given her cue in the three path on the turn, chases the winner into the stretch and weakened. NICKY JOLENE settled just off the pace, dropped back with five furlongs to run, fell to the rear while three then two wide on the turn and faltered then was eased but walked off.
