Purse \$125,000 (includes \$25,000 CBOIF – California Bred Owner Fund) **FOR GOLDEN STATE SERIES ELIGIBLE CALIFORNIA BRED OR CALIFORNIA SIRED FILLIES, TWO YEARS OLD.** By subscription of \$125 each, which shall accompany the nomination, Closed Thursday August 24, 2023 with 9 or by supplementary nomination of \$1,250 each (Non-Golden State Series eligible horses, \$25,000 to supplement — which will make that horse eligible to all future Golden State Series stakes) by closing time of entries. All horses to pay \$1,875 additional to start, with \$125,000 Guaranteed, of which \$71,250 to first, \$23,750 to second, \$15,000 to third, \$7,500 to fourth, \$5,000 to fifth and \$2,500 to sixth. 124 lbs.; Non-winners of \$50,000 other than maiden or claiming allowed 3 lbs.; of a race other than claiming, 5 lbs. High weights preferred. Total non-claiming earnings will determine preference of horses with equal weights. A trophy will be presented to the winning owner. *\$50,000 to the winner.

CRAZY HOT ducked in leaving the gate, straightened out and went up to clear from inside, showed the way two wide then along the inside around the bend, continued to clear into the final furlong, put to right handed urging midstretch and held safely. **PRANCINGTHRUPARIS** away quickly, chased outside a rival leaving the backstretch then three wide into the turn, was closest in pursuit in the two path entering the stretch and whittled the gap on the winner late. **FLY A FANTASY** chased widest up the backstretch, rounded the bend four wide and was along for the show. **BLEVYS TIGER** broke well then took hold shortly after the start, raced greenly up the backstretch and steered out, navigated the turn four then three wide and flattened in the lane. **PUTT FOR DOUGH** allowed to settle early, moved closer and went inside rivals into the turn, saved ground around the bend, raced a bit off the rail into the lane and weakened. **TALENT FOR GOLD** forwardly placed off the rail up the backstretch, dropped back two to three wide on the turn and tired. **DUE TO A TIMER MALFUNCTION THE RACE WAS HAND-TIMED.**
