A \$100 supplementary nomination may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth and 3% to fifth. \*(Not part of the announced gross purse, the FTBOA offers \$25,000 to the owner of a registered Florida-bred finishing first, paid directly by FTBOA). Weight: 122 lbs. Non-winners of a race other than maiden or claiming allowed 2 lbs; a race other than claiming, 4 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the race.

MATTINGLY settled off the pace while racing two wide, tipped three wide to advance nearing the quarter pole, angled further out in upper stretch, seized command leaving the eighth pole, drifted out nearing the sixteenth marker and drove clear. OKIRO raced off the pace two and three wide, swung five wide turning for home, rallied outside, steadied off the winner's heels nearing the sixteenth pole and could not gain any further on that foe from there. ESPERON set the pace in the two path to midstretch and was outfinished. PREVENT raced in range inside and lacked the needed rally. EL PRINCIPITO failed to menace while racing three and four wide. AN OBJECTION LODGED BY THE RIDER OF OKIRO AGAINST THE WINNER FOR ALLEGED INTERFERENCE IN THE STRETCH WAS NOT ALLOWED.
