A \$100 supplemental nomination fee may be made prior to time of entry. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. *(Not part of the announced gross purse, the FTBOA offers \$25,000 to the owner of a registered Florida-bred finishing first, paid directly by FTBOA). Weight: 123 lbs. Non-winners of a stakes race or two races other than maiden, claiming or starter, 3 lbs.; a race other than maiden, claiming, or starter, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race.

TIME PASSAGE set the pace in the three path, tipped into the two path underrousing going into the far turn, floated out to the four path at the top of the stretch, and dug in to hold of an outer foe. COCO bumped with an inner foe at the start, tracked in the five path, was cued from the three path into the far turn, took aim from the six path entering the stretch, and ran on for place. TO THYSELF B TRUE chased in the four path, was driven in the three path around the far turn, and kept on for show. BATUCADA rated in the two path, was ridden along the inside into the far turn, but evened out from the two path in the stretch. WRITTENIN THE STARS trailed in the six path and never threatened. FLAKES was fractious in the gate and bumped with an outer foe, stalked inside but was done after a half.
