Supplementary nominations may be made by the closing time of entries for a fee of \$2,000 which qualifies to start. \$150,000 Guaranteed. After paying 2.5% of original purse to the owners of horses finishing 6th through last, 60% of the remaining purse will be paid to owner (s) of the winner, 20% to second, 10% to third, 6% to fourth and 4% to fifth. WEIGHTS: 124 lbs. Non-winners of \$60,000 in 2023 allowed 3 lbs.; \$50,000 in 2023 allowed 5 lbs.; \$35,000 in 2023 allowed 7 lbs. (Maiden and Claiming races not considered in allowances). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Closed Tuesday, November 28, 2023 with 20 nominations.**

VALENTINE CANDY away in good order, pressed in the four path up the backstretch, three wide bid through the turn, kicked strongly clear under steady handling the final furlong. WILLY D'S in mid pack outside, four wide through the turn, lugged in a bit upper stretch, rallied willingly for the pace in determined fashion late, no match for the winner. ANDY'S CANDY void of early foot, three wide through much of the turn, came four wide for the drive, solid rally too late. MARKET STREET in the second fight toward the inside, asked through the turn, not enough late for the pace while between foes for the place. MOLLY'S TOWN broke in good order, relinquished the advantage, went after that foe into the turn, took over, held a narrow advantage late in the bend, headed by the winner and began to fade. GENERAL SHIPMAN within striking distance three wide, four wide into the lane, lacked a closing response. FROST FREE broke back, was hustled up the rail to show the way early, headed into the turn, weakened. CEEPEEGEE in mid pack early, shuffled back in traffic with just over a half remaining. BYE BYE LIAM in mid pack, tired. DREWMANIA saved ground to no avail. SWEET SODDY J was finished early, trailed in.
