5 FURLONGS. (563) ORLEANS S. Purse \$75,000 (includes \$75,000 Other Sources) FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD. No nomination fee, or start fee, \$750 to enter. Supplemental nomination of \$1,500 will be accepted at time of entries which will include all fees. With \$75,000 Guaranteed to be divided per the purse structure for stake races in the condition book. Weight: 123 lbs. Winners of \$35,000 twice since July 5, 2023 to carry an additional 2 lbs. Non winners of a stake race allowed 3 lbs.; Non winners of two races other than maiden, claiming, or starter, or state bred since July 5, 2023 allowed 5 lbs.; such a race since July 5, 2023 allowed 7 lbs. Preference to horses with the highest earnings in 2023 (at time of entry). Different owner and same owner entries will have equal draw according to preferences. Trophy to the winning owner.

JUMPIN JUDY vied for the lead from three wide then moved up to take the lead at the quarter pole and drew off to prove best. FLASHY MEG raced in the middle of the pack to the turn then made a five wide bid through the turn and chased the winner home to be a clear second. CALABRIAN QUEEN pressed the pace from four wide then fell back on the turn but made a rebid to save the show. TWO MINUTE DRILL was last away then rushed between horses at the three furlong marker and kept on but flattened out in the stretch. BLESSED ASSURANCE trailed the field early but steadily advanced through the turn and tipped out to six wide in upper stretch for a rally. WON DAY raced in the middle of the pack from three wide but failed to menace. GRACIE DIAMOND was in the middle of the pack in the two path to the turn then moved in to save ground around the turn and passed tiring rivals. BEYOND AWESOME saved ground but was not a threat. SOY UNA DAMA (CHI) co-led from the inside to the quarter pole and tired. TIZ MAGIC co-led from the two path to the quarter pole and faded.
