Free Nomination by Saturday, February 10. \$550 to enter, \$550 additional to start. Supplemental nominations of \$2,000 will be accepted at time of entry which shall include all fees. \$100,000 Guaranteed of which 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight: 122 lbs. Maidens allowed 5 lbs. Starters to be named through the entry box by the usual time of closing. The Louisiana Broodmare of the year Lipstick Junky Stakes will be limited to twelve (12) starters. Winners will be preferred then preference to horses that have accumulated the highest lifetime earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee or supplementary nomination fee if applicable. A trophy will be presented to the winning owner. Nominations closed Saturday February 10th with 10.

ACCOMMODATE EVA was bumped between rivals at the start, tracked from midpack two wide and between horses, pursued with run just behind the leaders three wide and among foes turning for home, smoothly tipped to bid four wide entering the lane and kicked clear. EMILY'S BULLET took contact from outer rivals and got knocked off stride soon after the start, settled off o the pace along the inside, shifted outside of rivals and to the five path in upper stretch, then rallied to gain place in the final sixteenth. LIGHTOFMAINE leaned out and bumped a rival at the start before being knocked into an inner foe soon after, stalked along the inside, but was blocked and shuffled back behind a tiring rival nearing the lane, shifted out and re-rallied three wide and between horses to narrowly reach show. CLEARLY A TEST leaned in and bumped a rival at the start, pressed two wide, bid along with an outer rival turning for home, got outkicked by a wider bidder in upper stretch, kept on willingly but got nailed at the wire for show. MAGNOLIA AVENUE broke a step slow, was floated inwardly and put to crowded quarters by an outer foe forcing her to bump an inner rival at the start, settled off of the pace four wide, inched closer under urging around the far turn, got outkicked while getting floated three wide entering the lane and yielded. TOMMIE G broke inwardly and forced trouble for inner rivals, stalked three wide, bid at the quarter pole, vied entering the lane, but was outkicked by an outer bidder in upper stretch and faded between horses. PLUM WINE broke a step slow before being bumped by an outer rival at the start, traile d in the three path, swung out to the eight path in upper stretch and failed to factor. WONDERRAND dislodged her rider pre-race, set the pace along the inside, got headed by a pair of outer bidders at the quarter pole and stopped.
