ANTIFONA (FR) broke a step slow, unhurried in the early going, moved inside for the turn, angled out approaching the dirt, came five wide into the stretch, rallied to the front midstretch and kicked clear in the final sixteenth. ZONA VERDE (IRE) saved ground around the turn off the pace, moved out entering the lane, lacked room between rivals in upper stretch, altered out into the clear, came with a late run and finished well for second. ALLURING stalked from inside then a bit off the rail late on the bend, shifted in and impeded ELEGANT at the eighth pole, finished determinedly between rivals late and gained third. VISUALLY chased three deep into the turn, rounded the bend three to four wide, brushed with inner rival crossing the dirt, drifted in a bit at the eighth pole and got edged for the show honors. DIAL A FRIEND vied three deep early then dueled outside a rival into the turn, inched ahead at the quarter pole, cleared across the dirt, lost command midstretch and weakened in the late stages. SEA DANCER chased out of range in the two path entering the turn, moved out and left the dirt four wide, then failed to rally when asked in the lane. GRANNY BUDGIE (GB) broke a step slow, chased off the inside near the back, went three wide into the turn, moved out to the four path then angled back in late on the bend, altered out from behind trouble rivals midstretch and failed to threaten. VOODOO MAGIC (FR) broke a bit slow, trailed four wide into the lane and passed tired rivals. GIRL OF MY DREAMS vied for the lead inside a pair of rivals then ceded command and chased two wide into the turn, remained off the rail around the bend, brushed with outer rival crossing the dirt, had to take up at the eighth pole and was not persevered with. ELEGANT vied for the lead between rivals then dueled from inside into the turn, kept the pressure on the lead to the quarter pole, lost touch with that rival crossing the dirt, continued within striking distance on the fence in upper stretch, then got impeded by ALLURING at the eighth pole causing the rider to lose his right iron and was not persevered with. JULIAS DREAM sat off the pace in the early going, spun five wide into the lane and came up empty when called upon. FOLLOWING AN INQUIRY, THE STEWARDS DISQUALIFIED ALLURING FROM THIRD TO TENTH FOR SHIFTING IN AND IMPEDING ELEGANT AT THE EIGHTH POLE, CAUSING HER RIDER TO LOSE HIS RIGHT IRON AND COST HER A CHANCE AT A BETTER PLACING.
