CATCHING FREEDOM rated back between hoses soon after the start, trailed, picked up stride in the five path around the far turn before swinging to the eight path entering the lane, rallied widest delaying his lead change until midstretch, sustained progress to bid entering the final sixteenth and drove past. HONOR MARIE laid well back in the three to four path, shifted out to the seven path entering upper stretch, rallied along with an outer foe to bid at the sixteenth pole, but got outkicked. TUSCAN GOLD tracked four wide, pursued under urging between horses around the far turn, sustained his chase through midstretch, but flopped back to his left lead while getting outkicked by an outer pair at the sixteenth pole, kept on well and edged show late. TRACK PHANTOM showed the way in the three to two path around the first turn, led from an outer prompter around the far turn, held sway into the final furlong, but was bested by wide bidders at the sixteenth pole and yielded. COMMON DEFENSE pressed the leader from the four to three path early on, vied around the far turn, chased his inner counterpart in upper stretch, but flopped back to his left lead at the furlong grounds and gave way between horses. ANTIQUARIAN broke through the gate pre-race, then bumped with his outer stable-mate at the start, pursued from midpack in the three path, chased five deep while attempting to creep closer around the far turn, but flattened out between horses in midstretch. AGATE ROAD bumped with an inner foe at the start, lacked speed along the inside, awaited racing room in the three path around the far turn, shifted four wide entering the lane and moved up. NEXT LEVEL saved ground off of the pace, but to no avail. AWESOME RUTA raced forwardly two wide and between horses, but faded through the lane. HALL OF FAME stalked along the inside but weakened through the lane. REAL MEN VIOLIN laid off of the pace two wide, weakened and was eased through the final furlong.
