5 FURLONGS. (Turf) (.533) SILKS RUN S. Purse \$100,000 (plus \$20,000 FTBOA – FL TB Owner Brdr Assoc Fund) FOUR YEAR OLDS AND UPWARD. Free nomination by Sunday, March 4. \$1,000 to enter. \$100,000 Guaranteed A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers up to \$20,000 to the owners of Registered Florida-breds, divided \$10,000 to the winner, \$6,000 to second, \$4,000 to third). Weight: 124 lbs. Non-winners of a graded stakes since September 1 allowed 2 lbs.; a stakes race since then, 4 lbs.; three races other than maiden, claiming, starter or state-bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners 2022–24, stakes-placed 2023–24, non-restricted stakes winners 2023–24, then by highest career earnings. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at Five Furlongs) (Rail at 45 feet).

COPPOLA laid up close under a hold inside but steadied slightly going into the turn, was coaxed from the rail passing the quarter, tipped out to the two path passing the eighth pole, and kicked on to be up in the final strides. PANTHER ISLAND chased inside, tipped out to the four path turning into the stretch, had to alter further out passing the eighth pole, and ran on to split place. YES I AM FREE got bumped but an inner foe at the start, set the pace in the two path, was nudged a long around the turn, opened slightly in upper stretch, but was caught by the winner in the closing stages, and held onto a share of place. BIG INVASION raced well back in the three path, swung out to the six path under a ride turning into the stretch, and stayed on but made no impact. KANTHARI broke out and bumped an outer foe, stalked in the three path, swung from the four path under drive turning into the lane, but was one paced. ITSALLCOMINTOGETHA tracked in the three path but flattened from the five path in the stretch. ROCKCREST raced off the pace in the two path and never menaced. STORM THE COURT got rank and broke slowly, then trailed throughout.
