OKIE SMOKE chased the pace from the outside, raced four wide around the far turn and finished willingly to the wire. CHASIN JASON chased the pace from the inside, angled out through the stretch and closed in mildly. NORWAY BEACH dueled early along the rail and faded. LEGACY ACCOUNT dueled two deep from the outside of rival and gave way. R D C POSSE void of early speed, swung six wide near the three sixteenths pole and lacked a bid.
