ZEITLOS rated off the early pace, continued confidently ridden still unaskedaround the turn, swung four to five wide into upper stretch, given cue, responded gamely, roused forward to duel three deep, dug in under an all outdrive and prevailed. DAZZLING BLUE raced near midpack thr ough the early going, giv en cue four wide entering the upper stretch, advance dand dueled between rivals in the final furlong, battled into final stages and got denied nearing the wire. HAPPY AM I was forwardly placed while a bit tight along the rail in early stages, stayed inside and waited for a clear path ar ound the turn, cut the corner entering the lane, roused forward to duel for the lead, raced heads apart then yielded in final stages. POSITANO SUNSET raced off the early pace, cont inued unhurr ied around the turn, launched an outside bid heading into thelane and edged closer in the final sixteenth. SPEEDY TRAVELER held a slim lead in early stages, came under pressure late on the turn, fought back in the upper stretch then weakened past the furlong marker. CURRENT CLIMATE raced in range in the opening quarter, moved up into close contention late on the turn, vied for the lead into the final furlong then gave way. LAST LEAF raced just out of striking distance in the opening quarter, continued in contention while urged between rivals around the turn, failed to sustain bid enter ing upper str etch and weakened. BACKYARD MONEY raced in the back, swung five wide int o the lane and had no response. CONDENSATION raced in range thr ough the backstr etch, edged up into close contention late on the turn then faltered thr ough the lane.
