Supplementary nominations may be made at the time of entry Wednesday, March 19, 2008 by payment of \$2,500 each (includes all fees). \$50,000 Guaranteed. After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a Sweepstakes allowed, 2 lbs.; two races other than maiden or claiming, 4 lbs.; a race other than claiming, 6 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to twelve starters. CAVALRY within striking distance, raced in the five path around the bend, angled out for the drive but lodged only a mild bid to be up for the place. STORMIN YANK forwardly placed outside, moved closer six wide midway through the turn but could not sustain the bid. G AREYOUKIDDING forced the pace from the start, was four wide on the turn, held on well to the stretch and tired. LITTLE NICK vied for the lead in the three path, held on well for a half and gave way. BEARSREADY outsprinted in the four path, could not menace. BERRY'S PRIDE was no factor.
