

1 1/16 MILES. (1.422) 23RD RUNNING OF THE RUSHAWAY. Purse \$100,000 FOR THREE-YEAR-OLDS. By subscription of \$100, \$500 to enter and \$500 additional to start. Supplementary nominations may be made at the time of entry Wednesday, March 19, 2008 by payment of \$5,000 each (includes all fees). \$100,000 Guaranteed. After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 121 lbs. Non-winners of a Sweepstakes at a mile or over allowed, 2 lbs.; A Sweepstakes, 4 lbs.; a race other than maiden or claiming at a mile or over since December 5, 6 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to twelve starters. Preference to start will be given in the following order: Graded/Group Stakes Winners (in order I-II-III), stakes winners, then highest career earnings. All Lane's End nominees are automatically nominated to this race. Failure to draw into the race cancels all fees. Closed Wednesday, March 12, 2008 with 5 Nominations. Also includes an additional 156 Nominations to the 37th running of the \$500,000 Guaranteed Lane's End Stakes, Grade II.

BIG GLEN in hand while within striking distance and four wide, moved closer on his own after a half, angled inside the leader in upper stretch, challenged with a furlong to go and proved best while along the inside the final furlong. MINER'S CLAIM set a comfortable pace while unhurried and in the four path, moved in a bit when battling on the second turn, responded willingly when headed just after going six furlongs, dug in when the winner gained a narrow advantage just inside the furlong marker and held on gamely. ICABAD CRANE prominent five wide, moved a bit closer in the five path on the second turn, stayed on well to inside the final furlong and weakened. CAPE OF STORMS prompted the pace four wide, challenged in earnest before a half, gained a short lead after six furlongs, held on well to the final sixteenth and tired. TARGE reserved four wide, made a solid five wide middle move but could not sustain the bid. TEJANOS ELIMINATOR prompted the early pace along the inside, held on well to the stretch and tired. MY SEA OF FIRE five wide on the first turn, was no threat. ACTING OUT could not menace. HOLIDAZE a bit rank early when reserved while close up and off the rail, gave way the final quarter.
