

1 1/8 MILES. (Turf) (1.40) 20TH RUNNING OF THE JENNY WILEY. Grade II. Purse \$200,000 FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD. By subscription of \$200 each, which should accompany the nomination or by Supplementary Nomination of \$10,000 at time of entry (includes entry and starting fees). \$1,000 to enter and an additional \$1,000 start, with \$200,000 guaranteed, of which \$124,000 to the owner of the winner, \$40,000 to second, \$20,000 to third, \$10,000 to fourth and \$6,000 to fifth. Weight: 123 lbs. Non-winners of Grade I stakes at a mile or over on the turf since October 5 allowed 2 lbs.; A Grade II stakes at a mile or over on the turf in 2008, 4 lbs.; A graded stakes at a mile or over since May 5, 6 lbs. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner. Closed Wednesday, April 2, 2008 with 31 nominations. In the event that this race is taken off the turf it will be contested at Eight and One Half Furlongs on the main track.

RUTHERIENNE settled in behind rivals early, was patiently handled behind slow fractions, split horses in the final furlong four wide, then proved gamely best in a stiff drive. STORMY WEST, always well placed while between foes three or four wide to the head of the stretch, eased out wider on the course when straightened for the drive, was with the winner while outside RUTHERIENNE in the final furlong but wasn't good enough. LADY OF VENICE (FR), unhurried early and four wide, came out ten abreast leaving the quarter-mile ground to make her run, loomed boldly in the late going and slowly was gaining at the end. ROSHANI went up between horses to press the pace early, battled with CANDY BALL while outside that one around the far turn and into the stretch, stuck her head in front at the furlong grounds but couldn't sustain the needed momentum. PRECIOUS KITTEN, up close early, was eased back to stalk the pace four or five wide from the first turn on, raced within easy striking distance to the stretch and came up empty. BIT OF WHIMSY, briefly in front after the start, forced the pace four wide to the head of the stretch and couldn't continue. CANDY BALL went up two or three wide to gain the lead entering the first turn, went along under careful handling, stepped slow fractions while battling inside of ROSHANI, lost the edge nearing the eighth pole and weakened gradually. SWINGIT, outrun three wide to the stretch, eased out six wide for the drive but had no rally. ARRAVALE tracked the pace four or five wide to the head of the stretch, fanned seven wide for the drive and was empty. SEALY HILL raced within easy striking distance while near the inside to the upper stretch and faltered.
