By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry (includes entry and starting fees). \$500 to enter and an additional \$500 to start, with \$100,000 added, of which 62% of all monies to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Three year old fillies, 117 lbs.; Older fillies and mares, 124 lbs. Non-winners of \$45,000 twice on the turf since October 5 allowed 3 lbs.; \$45,000 on the turf since October 5, 6 lbs. DANCEROTHEREALM (GB) outrun early, commenced her rally three wide on the turn, angled out for the drive, was carried out in upper stretch when TALETOBETOLD drifted out a bit then closed fast to be up in time. JUST FOR KEEPS sprinted clear, set the pace off the rail, angled out a bit for the drive, led the field to the final sixteenth, swerved out when roused left handed in deep stretch and was outfinished. KINDLING within striking distance off the inside, moved out four wide late on the turn, was carried out in upper stretch, angled in a bit for a clear path and closed well late. JAZZY (ARG) outrun three wide, finished willingly late. TALETOBETOLD forwardly placed three wide, drifted out a bit in upper stretch, was straightened and while gaining steadily on the leader, steadied late when that one swerved out. BEN'S GRAND BABE outrun early, raced off the inside on the turn and lacked a solid closing bid. FANLIGHT FANNY close up along the inside, made a mild gain to midstretch but weakened late. TALE OF THE DEVIL reserved along the inside, could not menace. POLA'S PLACE close up from the start, steadied approaching the turn when JUST FOR KEEPS angled in, stayed close up to the stretch and gave way. FOLLOWING A FOUL CLAIM BY THE RIDER OF TALETOBETOLD, JUST FOR KEEPS WAS DISQUALIFIED AND PLACED FIFTH FOR INTERFERENCE IN DEEP STRETCH.
