

1 MILE. (Turf) (1333) 19TH RUNNING OF THE CHURCHILL DISTAFF TURF MILE. Grade III. Purse \$150,000 FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD. By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 at time of entry. \$750 to pass the entry box; \$750 additional to start, with \$150,000 added. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Three-year-olds 117 lbs.; Older 124 lbs. Non-winners of \$60,000 twice at a mile or over on the turf since September 3, allowed 2 lbs.; a graded sweepstakes on the turf in 2007-2008, 4 lbs.; \$45,000 twice on the turf in 2008, 6 lbs. Starters to be named through the entry box at the usual time of closing. All supplementary nominations are required to pay entry and starting fees if they participate. Trophy to winning owner. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy). Closed Wednesday, April 9, 2008 with 42 Nominations. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at one mile.)

BAYOU'S LASSIE rated on the pace while saving ground, led the field through comfortable fractions, responded willingly when challenged by DREAMING OF ANNA in midstretch and edged clear late under pressure. DREAMING OF ANNA eased back off the winner entering the first turn to track that one, made a run to challenge when ready once in the stretch, battled to inside the final furlong and held on gamely to be second best. VENTURA forwardly placed off the inside, moved to a challenging position three wide late on the second turn but weakened in the drive. SHARP SUSAN unhurried along the inside, angled out for a clear path with a furlong to go but lacked the needed closing bid. NEW EDITION within striking distance off the inside, raced in the three path on the second turn and had nothing left late. DANZON unhurried for a half, angled out for the drive but could not menace. LADY CARLOCK outrun for a half, came to the outside for the drive but was no factor. V. I. P. PRINCESS within striking distance off the inside, tired.
