By subscription of \$100. \$500 to pass the entry box, \$500 additional to start, with \$100,000 Guaranteed, of which 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Supplemental nominations of \$1000 each will be accepted by Saturday, May 10, 2008 with all other fees due as noted. Weights Sunday, May 11, 2008. Preference to starters high weights on the scale. Horses may be placed on the also eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner. (If deemed inadvisable by management to run this race on the Turf course, it will be run on the main track at One Mile and One Sixteenth).

ROSHANI bumped with VALBENNY (IRE) when put in a bit close under the wire the first time, prompted the pace two wide, moved between rivals leaving the far turn to take command, edged clear after six furlongs, drifted out under left handed pressure inside the furlong marker then dug in gamely to prevail. LADY DIGBY stalked the pace three wide, gained ground leaving the far turn, lodged a bid to near even terms a sixteenth out then hung. VALBENNY (IRE) checked sharply when jostled passing the wire the first time, was a bit difficult to settle along the rail, moved closer nearing the far turn, angled out mid way on the final turn then lacked a solid stretch response. STORMY WEST settled back early, angled out four to five wide entering the lane but failed to respond. LE CORDON BLEU came in some when advancing to command in the opening quarter mile, set a slow pace along the rail, was collared leaving the far turn, faltered entering the lane and was not abused. An objection by the rider of LADY DIGBY against the winner for alleged interference in the stretch was not allowed. There was a stewards' inquiry regarding the run into the first turn but no action was taken.
