MISSION APPROVED led early, set the pace under strong restraint then held sway under a steady drive. RAHY'S ATTORNEY stalked from the rail, closed into the stretch, finished determinedly but hung late. DUBAI GOLD, well back early, closed gradually on the far turn but never threatened. BENZ BOY stalked the pace, was still in reasonable striking range on the far turn, was hustled into the stretch and evened out. COLORFUL JUDGEMENT, well back early, finished gamely but never reached contention. PELLEGRINO (BRZ) raced in the middle of the pack and lacked a rally. IT'S LIKE THIS was close early, dropped back and lacked a rally. MARCHFIELD raced midpack, lacked a closing response. MY IMPERIAL DANCER, in range early, was hustled into the stretch and flattened out. SHILLELAGH SLEW dropped back on the backstretch, raced well off the pace then lacked a closing response. MIKE FOX was always off the pace and lacked a rally. TAP SHOW stalked under strong restraint, gave way late turn and tired.
