SEASIDE RETREAT stalked the pace then moved closer and forced the issue three-wide on the far turn, bid past midturn, dueled into the stretch and gained a short lead three-sixteenths out then drove clear. STRIKE A DEAL bid early on the backstretch then was under strong restraint setting while settling a pressured pace, dueled from late turn and yielded grudgingly in the stretch. FRENCH BERET, in range two-wide, was hustled four-wide late turn and finished all out through the stretch. RAHY'S ATTORNEY stalked four-wide on the backstretch and far turn, closed up at the top of the stretch then evened out. INDEPENDENT GEORGE held a short early lead, was headed early on the backstretch, stalked the leader then moved up inside him entering the turn but could not match strides, chased into the stretch then tired in the final furlong. CAN'T BEAT IT raced off the pace two then three-wide, was hustled late turn, angled out at the top of the stretch but lacked a strong closing response. GHOST HOUR raced off the pace along the rail, was roused two-wide late turn, closed up and was contentious to the final furlong and tired.
