

1 1/8 MILES. (1,422) 23RD RUNNING OF THE KENTUCKY CUP DISTAFF. Grade III. Purse \$100,000 FOR FILLIES AND MARES THREE-YEARS-OLD AND UPWARD. By subscription of \$100, \$500 to enter and \$500 additional to start. Supplementary nominations may be made at the time of entry Wednesday, September 24, 2008 by payment of \$5,000 each (includes all fees). \$100,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Three-Year-Olds; 118 lbs.; Older; 122 lbs. Non-winners of a Graded Stake at a mile or over since March 15, allowed 2 lbs.; Non-winners of a Sweepstakes at a mile or over in 2008, 4 lbs.; \$30,000 at a mile or over in 2008, 6 lbs. This race will be limited to twelve (12) starters. Preference to start will be given in the following order: Graded/Group Stakes Winners (in order I-II-III). Stakes winners, then highest total earnings in 2008. Starters and riders must be named through the entry box by the usual time of closing. Failure to draw into the race cancels all fees. BEAR NOW was forwardly placed under a snug hold two wide, swiftly ranged into striking distance through the second turn, assumed command entering the stretch and steadily drew clear. UNFORGOTTEN was unhurried into stride, swung five wide leaving the second turn to make a late rally and finished willingly to earn the place. DEVIL HOUSE opened clear to set the pace, was collared after six furlongs, gave way but had enough left to hold the show. MARQUEE DELIVERY was hustled along three wide to attend the pace, but weakened from between horses entering the stretch and faded. FANCY FUSAICHI settled in the second flight four wide and went evenly. TAZARINE settled along the inside in a contending position but lacked a response when called upon. MAREN'S MEADOW contended between horses through the second turn and stopped.
