PROCEED BEE forwardly placed three wide, raced four wide on the second turn when moving to challenge, could not keep pace with JACK SPRATT into the stretch but came again and wore that one down. SMART SHOT within striking distance, moved closer in the four path on the second turn but lodged only a mild bid for the place. JACK SPRATT vied for the lead along the inside, drew clear into the stretch but faltered late. RELVADO outrun early, advanced four wide out of the second turn and finished willingly. ROCKIN' JOE reserved three wide, lodged a mild late bid. SOUTH FORK LODGE within striking distance, raced five wide on the second turn and weakened in the drive. PRESENTS FOR BERTI forwardly placed from the start, raced in the three path on the second turn and lacked a rally. NINTH CLIENT close up three wide, held on well to midstretch and tired. CHILLINESS within striking distance off the inside, gave way. TENMOR was no threat. MY BOY JO alternated for the lead off the inside and tired late. CHANGING STORM five wide early, was outrun.
