WILD PROMISES stalked the pace, eased three wide leaving the far turn, rallied to gain command inside the eighth pole, then edged away. ELUSIVE LADY vied for the lead along the rail, opened a clear lead in early stretch but couldn't resist the winner while continuing on with good courage for the place. SNOW CONE reserved early, angled out for the stretch run and closed with a mild response to gain the show. JULIA TUTTLE vied for the lead outside ELUSIVE LADY to the top of the stretch, then gave way. ZIP TRICK steadied to avoid running up on rivals racing into the first turn, saved ground into the stretch and tired. ZEE ZEE rated off the pace, steadied in behind rivals racing under the wire the first time, continued to race in striking position to nearing the stretch, then faltered. BEL AIR SIZZLE was never a factor after hesitating at the start. PEACH FLAMBE stalked the pace three wide into the far turn, then faded.
