

1 1/8 MILES. (1473) 51ST RUNNING OF DONN HANDICAP. Grade I. Purse \$500,000 (includes \$100,000 BC - Breeders' Cup) FOR FOUR YEAR OLDS AND UPWARD. By subscription of \$500 each by Saturday, January 17, 2009 , which shall accompany the nomination, \$5,000 to pass the entry box and \$5,000 additional to start, with \$400,000 Guaranteed and an additional \$100,000 from the Breeders' Cup Fund for Cup nominees only. All fees shall be paid prior to the start of the race. The host association monies to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Breeders' Cup Fund monies also correspondingly divided providing a Breeders' Cup nominee has finished first through fifth. Any Breeders' Cup Fund monies not awarded will revert back to the Fund. Weights: Saturday, January 24, 2009. Starters to be named through the entry box by the usual time of closing. This race will be limited to 12 Starters, with Also Eligibles. High Weights Preferred with second preference to horses with the highest lifetime earnings. Trophy to the winning owner. Nominations closed February 7, 2009 with 17 nominations.

ALBERTUS MAXIMUS in hand while prompting the pace outside FINALLYMADEIT, moved up to engage that one midway of the far turn, then edged that rival to the wire after a prolonged duel. FINALLYMADEIT quickly moved to the fore, made the pace along the inside, responded when challenged by ALBERTUS MAXIMUS on the far turn, then duelled with that rival to deep stretch and was just edged to the wire in a game effort. EINSTEIN (BRZ) was caught out wide on the first turn, moved up to stalk the pace four wide into the stretch, then couldn't gain on the top ones while holding the show. ARSON SQUAD rated off the pace, advanced off the rail to reach contention in the stretch but had no further response. SIR WHIMSEY tracked the pace along the inside into the stretch and weakened. GREAT HUNTER reserved off the pace after being caught out wide on the first turn, raced four wide on the far turn and tired. ANAK NAKAL was outrun. A. P. ARROW was done early and eased in the stretch run. BULLSBAY tracked the pace three wide into the far turn, faltered and was eased in the final eighth. ON BOARD AGAIN chased the pace five wide to midway of the far turn, then faded and was eased in the stretch run.
