LADY CARLOCK unhurried early, swung out for the stretch run and rallied to be up in the final strides. MUSHKA stalked the pace three wide, rallied to gain the lead at the eighth pole but couldn't resist the winner in the closing yards. DROP A LINE steadied in behind the leaders soon after entering the first turn, stalked those rivals into the stretch and didn't do enough late. LONG APPROACH rated off the pace, angled out for the stretch run, then was checked at the sixteenth pole when unable to split rivals at the sixteenth pole and failed to recover. CALLWOOD DANCER (IRE) reserved off the pace, raced three wide around the far turn and closed some ground without threatening. TEJIDA rank under restraint while making the early pace, eased back to track FLIBBERJIBIT, was caught in tight trying to get through inside that rival on the far turn, made a run to reach near even terms for command at the eighth pole, then weakened. WAQUOIT'S LOVE well placed racing along the rail, was blocked in behind rivals through the final sixteenth, checked and gave way. FLIBBERJIBIT moved to take over from TEJIDA leaving the first turn, made the pace while in hand racing just off the rail into the stretch, then tired in the final eighth. The rider of LONG APPROACH lodged an objection against the rider of LADY CARLOCK for alleged interference at the sixteenth pole. The claim of foul was not allowed.
