DAYANARA ROSE sprinted to a clear lead while angling over to the inside, made the pace into the stretch, then drew away when asked. MYSTIC MIRACLE tracked the pace, angled out for the stretch run and closed to be up for the place while no match for the winner. LUCKY CEE CEE reserved after stumbling at the start, advanced along the rail to reach contention, came out under left-handed urging to bump STARSHIP KITTY at the eighth pole and gave way. STARSHIP KITTY chased the pace into the stretch, then was bumped by LUCKY CEE CEE at the eighth pole and tired. DEVILINAREDDRESS was no factor after breaking poorly. POET'S EYE checked from tight quarters in the chute, was outrun and eased in the final eighth. Following a stewards inquiry, LUCKY CEE CEE was disqualified and placed fourth for interference to STARSHIP KITTY at the eighth pole.
