After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. CLIFFY'S FUTURE was reserved early, angled into the five path inside the quarter pole then rallied in the stretch and drove past the leaders while clearing late under a steady drive. ZIEGFELD was unhurried early, swung widest into the lane and got up for place late while no match for the winner. TOCCE T ROCKET was back early, angled into the four path entering the lane and moved up in the stretch run. SUNDAYS BABY GRAND tracked the leader early then took over the lead briefly, angled into the three path inside the quarter pole and gave way in the stretch drive. NO INFLATION was well placed early, angled into the four path into the far turn then led in the stretch but faltered late in the final stages. FITZASLEW pressed the pace early then led the field briefly, angled off the rail into the far turn and faded late in the drive. SUMMER'S EMPIRE raced up close early, angled into the four path inside the quarter pole and was tired down the lane. NINTH CLIENT showed early speed then soon retreated.
