REDEFINED sprinted clear along the backstretch, extended her advantage on the turn, maintained a clear lead into midstretch, dug in when threatened in deep stretch and was fully extended to hold off the runner-up in the final strides. MERIWETHER JESSICA raced up close along the rail, waited briefly on the turn, angled out in upper stretch then gained steadily but could not get up. MOR CHANCES raced in traffic between horses midway on the turn, angled in while gaining near the quarter pole then finished willingly along the inside to gain a share. GIMME CREDIT was outrun for a half, swung five wide entering the stretch and rallied belatedly. ROLLERS prompted the pace between horses into upper stretch and weakened. LAW ENFORCEMENT angled in while trailing, swung four wide at the quarter pole and lacked a late response. MOHEGAN SKY raced in the middle of the pack while three wide for a half and steadily tired thereafter.
